In an increasingly AI-driven world, how can we advance justice, peace, and inclusiveness? The second EUPeace Conference will provide an interdisciplinary platform for discussing AI's far-reaching implications on societal conflicts, environmental justice, migration, human rights, and global health.

Building upon the expertise and contributions of the EUPeace Research Hubs, the conference will centre on the impact of AI in shaping contemporary global issues. Recognising the importance of a comprehensive and multi-disciplinary research landscape in fostering peace and justice, the conference also includes topics beyond Artificial Intelligence. Thus, the conference will bring together a wide range of disciplines, fostering a dynamic and diverse dialogue on the pressing societal challenges of our time. It will also provide valuable insights into how research enhances teaching by delivering current knowledge, enriching course content with practical applications, and stimulating critical thinking through evidence-based perspectives.

The conference features keynote lectures, panel discussions, and workshops, fostering dialogue among scholars, teachers, practitioners, and policymakers. Next to cutting-edge contributions on the conference topic "Advancing Justice, Peace and Inclusiveness in Times of AI", the EUPeace Research Hubs created a rich conference programme encompassing contributions from different methodological and disciplinary perspectives. This also includes presentations which focus on translating research into teaching and research-based teaching. Finally, the conference will provide the opportunity to participate in Creative Spaces which present an open space for transdisciplinary discussions of cutting-edge questions around the topics of peace, justice, and inclusive societies.

### **“Beyond the Places of Pain”**

This Creative Space explores the interdisciplinary convergence of social science and visual art, centred on the memory and representation of the 1992–1995 Bosnian War, with particular focus on the Srebrenica genocide. Initiated by a visual artist and an anthropologist—both direct witnesses to the conflict—this collaboration reimagines the role of creative expression in both scholarly and non-scholarly research, and vice versa.

Our work pushes disciplinary boundaries by fusing documentary, ethnographic, and artistic methods. Through the travelling exhibition *Beyond the Places of Pain* (in earlier iterations exhibited in BiH, EU, Australia and USA, mostly in the places where Bosnian diaspora live, including war and genocide survivors), we evoke personal and collective experiences of trauma, memory, and resilience. The multimedia exhibition—featuring photographs, texts, archival materials, drawings, sound, and video—honours the individuality of genocide victims, celebrating both their uniqueness and ordinariness, too often erased by statistics, collective categories, or grand national narratives. It also foregrounds the strength and endurance of survivors.

This Creative Space—in form of a public exhibition and a workshop—functions as a platform for dialogue and open-ended conversation, engaging actors beyond academia—artists, activists, educators, survivors, and community members (public)—whose participation actively shapes the work. Their insights and inputs help co-create an evolving, socially embedded, and ethically grounded narrative.

Coinciding with the 30th anniversary of the Srebrenica genocide, the societal relevance of this initiative is both profound and timely. While rooted in post-war Bosnia and Herzegovina, its themes resonate globally amid rising nationalism, forced displacement, and the erosion of democratic norms. In this context, our Creative Space fosters critical reflection on the politics of memory, human rights, and justice.

By embracing a methodology that is at once scholarly and artistic, subjective and collective, this Creative Space contributes meaningfully to the pursuit of peace, justice, and inclusive societies—key socio-humanistic challenges of our time.

### “Framing, enabling, and teaching the concept of justice in the context of climate change”

While a broad consensus exists in the scientific community on the causes of climate change and the mitigation actions to be taken, the policy direction for implementing these actions is continuously undermined by contingent events, also (but not only) in Europe, in a way that makes the transition to climate neutrality longer, ineffective, and ultimately inequitable. Indeed, climate change and decarbonization raise complex issues of equity involving several forms of justice, defined in the literature as distributive, procedural, recognition, corrective, and, more recently, transitional, meant as “how should policies be sequenced to make them bring us overall closer to an ideally just state” (Zimm et al., Nat. Clim. Change, 2024). Furthermore, intersecting climate change and social inequality involves accounting for themes like colonialism, racism, and capitalism, making the objective of defining and framing just transition concepts and actions a particularly challenging interdisciplinary effort. Yet, this is a topical issue that not only needs to be considered by researchers and policymakers but also needs to start being transferred to university classrooms.

A broad group belonging to the EUPeace ‘Climate Science and Just Transition’ Research Hub (RH) proposes a Creative Space focusing on Just transition, which will be analyzed and declined in several contexts, possibly corresponding to the main topics of the working groups created within the RH. The discussion, which will be based on the physical data on the impacts of anthropogenic emissions, will be enriched by at least one invited expert and fed by the fundamental contribution of policymakers at the EU level, who will be involved as actors beyond academia. Special attention will be paid to the transfer of Just Transition concepts into education, while in-person discussion and subsequent virtual exchange will lead to the writing of an opinion paper to be sent to an international specialized journal and the strengthening of a network devoted explicitly to this topical subject.

### “Social Mediation and Inclusive Justice: Bridging Grassroots Knowledge and Academic Perspectives in Europe”

This workshop offers a space for dialogue between grassroots practices and academic dynamics around social mediation, drawing on the innovative experience of the *Tour of Europe of Social Mediators* (ArleKin and ArleKin Pro) and the initiatives led by the City of Limoges in its priority neighborhoods. The aim is to explore how methodologies derived from social mediation can enrich academic and civic efforts to build more inclusive, just, and peaceful societies.

We invite mediators, researchers, students, and institutions to collectively reflect on the conditions that foster the recognition of experiential knowledge across Europe. The format will include life storytelling and collaborative mapping in order to identify transferable tools and approaches between cities and universities.

The workshop aims to co-create a transsectoral cooperation protocol to strengthen the recognition of skills acquired through social mobility and to lay the foundation for a mobile Living Peace Lab at the European level, inspired by “compagnonnage” practices.

### “Digital Tools and Women’s Pelvic Health Awareness”

This Creative Space will focus on the topic of women’s pelvic health, with a particular emphasis on the use of computational modeling and simulation to better understand the pelvic floor and associated disorders such as pelvic organ prolapse and incontinence. Drawing from ongoing research in medical imaging, biomechanics, and digital twin technologies, the event will explore innovative ways to increase public awareness, early diagnosis, and personalized treatments for pelvic floor dysfunctions.

This topic is of societal relevance as pelvic floor disorders affect a significant portion of the female population—particularly postpartum women and aging individuals—yet remain largely underdiscussed due to stigma and lack of awareness. These conditions can severely impact physical health, mental well-being, and overall quality of life. Through this Creative Space, we aim to bridge the gap between scientific research and public understanding, empowering women and communities to seek early interventions and support.

The Creative Space will adopt an interactive and transdisciplinary format that brings together researchers, clinicians, designers, and members of the general public. By integrating voices beyond academia, we will explore how digital tools can be co-developed and communicated to non-specialist audiences. The session will include guided discussions, visual demonstrations, and a participatory design thinking workshop to identify actionable strategies for improving education and outreach around pelvic health.



Our ultimate goal is to foster a deeper societal dialogue around women's health and contribute to a more inclusive and just approach to healthcare, resonating with the EUPeace mission.
