## SHORT DESCRIPTION

---

This course introduces learners to the foundational phase of problem solving in community engagement contexts: identifying, analysing, and defining the problem. Participants learn to distinguish symptoms from root causes, analyse complex or “messy” situations through multiple perspectives, and formulate clear, actionable problem statements that can guide meaningful intervention.

The course emphasises critical and reflective thinking, systems-informed approaches, and collaborative problem exploration with stakeholders. Learners will apply problem-structuring methods to social and public-policy challenges, with examples drawn from social policy and linked to social justice and inclusion. By strengthening these competences, the course prepares participants to engage more effectively in community-based initiatives, participatory projects, and evidence-informed responses to societal needs.

## LEARNING OUTCOMES

---

### Knowledge & Understanding

- Differentiate between ill-structured (“messy”) and well-structured problems.
- Describe common problem-analysis frameworks (e.g., 5W, systems mapping, problem trees).
- Identify and categorise key constraints, assumptions, and stakeholder perspectives shaping a problem situation.

### Applied Skills

- Formulate clear, neutral, and evidence-informed problem statements.
- Analyse underlying causes and causal relationships in complex problems.
- Apply visual structuring techniques (e.g., systems maps, causal loop diagrams) to organise and clarify problem dynamics.
- Evaluate and compare alternative problem framings and justify a selected definition based on context, stakeholders, and intended outcomes.

### TEACHING METHODOLOGY

---

The course is delivered in an online synchronous format combining short pre-recorded lecture inputs with interactive live sessions. During the course, participants work with practical examples and guided exercises linked to real community engagement contexts, allowing them to apply concepts collaboratively and reflect on their own communication and decision-making. Learning is consolidated through a final automatically evaluated quiz, which provides immediate feedback and confirms successful completion of the key learning elements.

### ASSESSMENT AND GRADING
